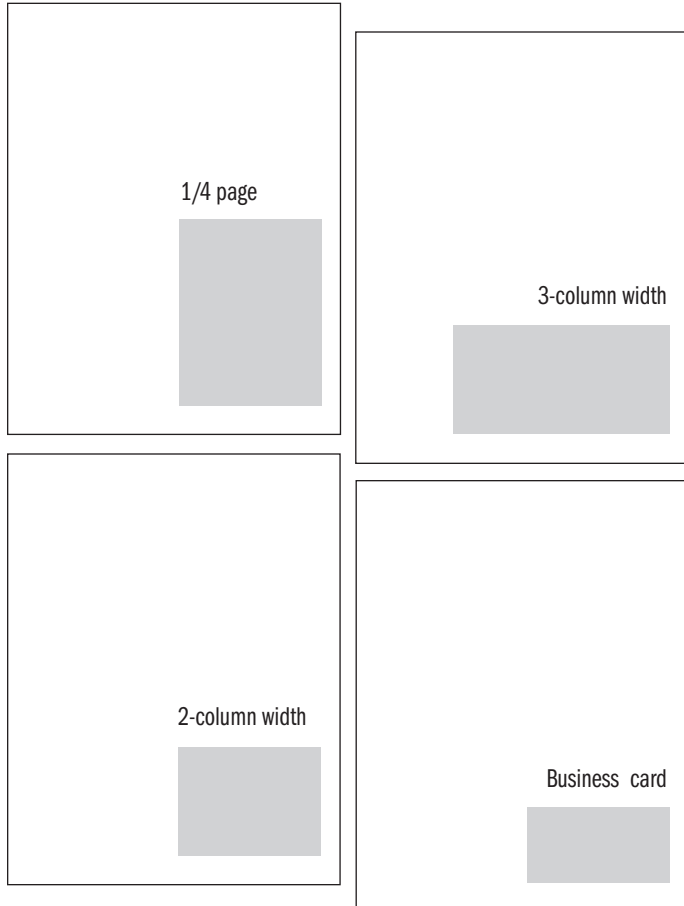

The Decatur FOCUS is printed in full color on an offset press in 4- and 6-column formats from digital files.



Mechanical Requirements

All ads are to be provided in digital format or as camera-ready art. Acceptable formats include PageMaker, Illustrator, Freehand, QuarkX-Press, .eps, .tif, .jpg and .pdf. Fonts and images must be included to ensure accurate reproduction.

The publisher reserves the right to regulate typography and graphical elements to conform with reproduction standards. Camera-ready art will be scanned. Publisher will not be held accountable for any loss of resolution or image quality.

Ads larger than size specifications will be reformatted accordingly, or charged at next full ad size if resizing is impossible.

Submittal Requirements

Ads should be submitted on CD or Zip disk, or via e-mail to info@lampe-farley.com. For recordkeeping, a hard copy should be delivered along with files on CD or Zip disk. If ad files are e-mailed, a hard copy must be delivered to the Decatur Development Authority at the address overleaf, or faxed to the DDA at 404/371-1593.

Production Fees

Production of advertisements or of necessary alterations to advertisements will be billed to advertiser. For assistance in production of ads, including design, photography, typesetting and paste-up, contact the DDA at 404/371-8386.

Advertising Regulations

Short Rates

If, within the term of an advertiser's contract, the advertiser does not use the amount of space contracted for, the advertiser will be billed for full price of each ad without discount.

Advertising Responsibility

The advertiser agrees to indemnify and hold harmless from and against any loss or expenses resulting from any disputes or legal claims based upon the contents or subject matter of such advertisement, including claims or suits for defamation, libel, violation of privacy, plagiarism, and copyright infringement.

Advertisements are published upon the representation that the advertiser is authorized to publish the submitted matter. Publishers of the Decatur FOCUS reserve the right to print the word "advertisement" on any copy which, in publishers' opinion, resembles editorial copy. Publishers reserve the right to reject any advertising submitted. Publishers assume no responsibility for artwork or photographs left 30 days or longer after the last contract insertion date.

Advertising Deadline

Ad space reservations and camera ready materials are due the first of the month prior to publication. For example, deadline for February issue is January 1st.

Cancellations

One-time insertions must be cancelled prior to noon on the 1st of the preceding issue month. Contracted cancellations must be submitted in writing and received by publishers prior to 4 p.m. on the 1st of the preceding issue month.

Billing Procedures

All first-time ads must be paid at the time of submission.
